Exhibitor: 10' X 10' Booth with table

Third page ads should fit 2 1/2" high x 9" wide maximum to allow for margins. Please include contact person's email and phone number, and attach advertisement content in email. Upon our review and notification to contact person of Conference acceptance of ad content and layout, instructions on directing payment (electronic funds transfer or check) will be forwarded.

Conference Bag Insertion Fee: \$300 for one event, or \$500 for both events to include small giveaway items, postcards, flyers, brochures (max. 8"x10") to supply 200 bags per event. (No cups or bulky items)

Deadline to receive items for bag insertion: 30 days prior to each Conference.
